1. Background

SME Development Finance Corporation (SDFC) is seeking to empanel vendors interested in providing vehicles to its customers through SDFC Financing Options. This initiative aims to enhance customer access to vehicles and promote SME development by providing financing solutions. This TOR outlines the requirements and evaluation criteria for vendors interested in participating in the empanelment process.

2. Objectives

The primary objective of this empanelment process is to identify and select qualified vendors who can offer a preferrable diverse range of cars through SDFC Financing Options. The empanelment aims to establish a partnership that benefits both SDFC's customers and the selected vendors.

3. Scope of Work

Interested vendors should submit comprehensive information about their company, product offerings, and their ability to collaborate with SDFC for offering Financing Options to customers.

Vendors should propose a framework for seamless collaboration with SDFC, including order processing and delivery,

4. Empanelment Criteria

Vendors interested in empanelment should meet the following eligibility criteria:

- 1. An entity that is a registered sole proprietor, partnership, or a company incorporated in the Republic of Maldives.
- 2. A demonstrated history of successfully importing a minimum of 10 (ten) number of vehicles (verified through import documents) during the past one year, ideally in partnership with financial institutions.
- 3. Should have a vehicle repair workshop or shall have an arrangement for the repair of vehicles with a vehicle repair workshop.
- 4. Capacity to provide a diverse range of vehicles to meet customer preferences.

5. Empanelment Process:

- 1. Submission of proposals by interested vendors.
- 2. Initial review of proposals by SDFC's evaluation committee.
- 3. Shortlisting of vendors based on the empanelment criteria.
- 4. Final selection and empanelment of vendors on SDFC's website.



6. Documents to be Submitted

To establish its eligibility and qualifications to perform the contract in accordance with the TOR, proposal must be submitted with the following documents & forms and any proposal submitted without these documents & forms will be disqualified.

- 1. Cover Letter
- 2. Form 1 Application for vendor registration
- 3. Form 2 Vendor profile and technical proposal
- 4. Details of previous collaborations with financial institutions, if any.
- 5. Outline of after-sales service infrastructure and customer support.
- 6. Tax clearance report
- 7. A copy of the vendor's Business Registration Certificate / Profile Sheet.
- 8. A copy of the vendor's GST Registration Certificate
- 9. Experience letters
- 10. Financial statement for the past year.
- 11. Bank statement for the past year
- 12. Board Resolution for companies/partnerships stating the authorized signatory and nominee on behalf of the business (draft format available on our website)

7. Product Requirements

- The vehicle should be a model from the last five years.
- The vehicle should be a hybrid or an electric car.
- The vehicle must have seating capacity for 4 passengers.
- The vehicles must have a trunk space of at least 350 liters.
- The windows must not be tinted (This is a requirement of the transport ministry)
- The car must have other specific requirements stated under the rules, regulations (inclusive of taxi regulation) and laws of the Maldives.
